Instruction for filling the form

- Form to use: "LMR_MOD.21.028 Form for results submission-radon_RNE.AL.DL.24.03"
- Filename: "DLXY_name of the form" (example: DL89_LMR_MOD.21.028 Form for results submission-radon_RNE.AL.DL.24.03)
- Unit of measure: radon concentration integrated in time (exposure) expressed in kBq·h·m⁻³
- Thousands separators: **no separator**
- Number of decimal digits: **0 (zero)**
- Fill a form for each lot: the Excel form contains a number of sheets as the number of bags sent by the participants.
- In the colored cell of the column "Device code", please insert the set code DLXY already sent to each participant.
- Values of radon exposure and of uncertainty (68% confidence interval) are compulsory.
- Results sent by participants must be directly comparable with exposure values given by the calibration laboratory. Transit correction is up to the participant lab. The Coordinator will use transmitted data as they are, without applying any correction. Trivial mistakes like wrong unit of measure or typos will not be corrected.
- Radon exposure measured by transit devices are required as well. The Coordinator will
 use this piece of information to identify possible problems during the proficiency testing
 steps.
- Data not transmitted will result in a reduction of the dataset on which the statistical analysis is performed. The analysis is still carried out if up to 50% of the elements of the dataset are missing; otherwise if less than half of the data set is available, no analysis is performed. Untransmitted data must be indicated with the symbol "#" in the file for the results submission.

Instruction for sending the form

- Please send the Excel file "DLXY_LMR/MOD.21.028 Form for results submissionradon_RNE.AL.DL.24.03" to **ptp-deng@polimi.it**, deadline **20/05/2025.**
- Sign a printed copy of "DLXY_LMR/MOD.21.028 Form for results submission-radon_RNE.AL.DL.24.03" (one sheet per page) and send the scan (or pdf version) to ptp-deng@polimi.it, deadline 20/05/2025. You can modify the transmitted Excel file only before the transmission of the scan/pdf and upon previous request by email. In the event of a mismatch between Excel and scan/pdf, the scan/pdf will prevail.
- The Coordinator will acknowledge both participants emails (Excel file and scan/pdf file) and inform about discrepancies, if any.
